**Finding of No Significant Impact  
Available for Public Review**

This notice advises the public that the Texas Department of Transportation (TxDOT) has issued a finding of no significant impact (FONSI) for the proposed US 380 Princeton project, and that the FONSI is available for public review. The proposed project would consist of the new location realignment of US 380 from FM 1827 to CR 560 in Collin County, Texas.

The FONSI and approved final environmental assessment (EA) are on file and available for inspection Monday through Friday between the hours of 8 a.m. and 5 p.m. at the TxDOT Dallas District Office, 4777 E.
