Project Need and Purpose

CORRIDOR **NEED**

- Q US 380 does not meet current freeway design standards
- Q Does not meet current and future traffic volumes
- O Does not have continuous bike and pedestrian connectivity
- Solution Is congested with reduced mobility

PROJECT PURPOSE

Improve US 380 to current freeway design standards

 Increase capacity to reduce congestion



- Increase mobility and connectivity
- Improve safety through a multimodal corridor




US 380 Princeton Project





Existing US 380 Typical Section

FM 1827 to CR 458*



In 2025, TxDOT is planning a road widening on the existing alignment:

- Six Lanes
- This typical section uses the future widening as existing conditions.

Current existing roadway conditions:

- Four lanes
- Raised median
- Discontinuous pedestrian accommodations

CR 458 to West of Lavon Lake & East of Lavon Lake to CR 560




Current existing roadway conditions:

- Four lanes
- Raised median (CR 458 to Lavon Lake)
- Continuous flush left turn lane (Lavon Lake to CR 560)
- Discontinuous pedestrian accommodations




Existing US 380 Typical Section

Lavon Lake – Bridges












Proposed US 380 Typical Section





FM 1827 TO WEST OF LAVON LAKE AND EAST OF LAVON LAKE TO CR 560 Improvements:





Environmental Review – Resources and Topics Evaluated

Environmental technical reports prepared for the proposed project assess potential impacts to the following resource categories:





Environmental Review – Resources

Traffic Noise



- FHWA Traffic Noise Model used to estimate existing and predicted traffic noise levels.
- One noise barrier on US 380 bridge structure at Princeton Crossroads neighborhood.

Community Facilities & Parks

- One community facility would be displaced: the Apostolic Church of Jesus Christ.
- Minimal amounts of ROW would be required from two parks: Twin Groves Park and Caddo Park.

Floodplains and Waters of the U.S.



- Portions of the project situated within FEMA designated 100-year flood hazard areas.
- Flood hazard areas are associated with multiple creek crossings.
- The proposed project would cross waters of the U.S. including Lavon Lake on bridge structures.

Historic



- One property eligible for listing in the National Register of Historic Places: Caddo Park Lavon Lake Historic District.
- The proposed project would require minimal ROW but would not result in adverse effects to the property.



Environmental Review – Right of Way (ROW)



Approximately 396 acres of new ROW would be required



Potential commercial and/or residential displacements



All ROW acquisition would be completed in accordance with the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended



Design Updates for Inclusion in Final Environmental Document Right of Way and Permanent Easement Requirements



Approximately 396 acres of new right of way would be required.




Increased acres of easement within USACE Wildlife Management Area from 21 acres to 22.93 acres.
